After the mulch settled it was discovered we had overpour on the four concrete pads which secure our benches. All Weather Contractors ground the overpour for a clean cut. Cost: \$590

All five of our handicap parking space signs were faded and have now been replaced by Fast Signs. Cost: \$925.82





Fitness Center Dumbbells

Heavier dumbbells were purchased for the fitness center. The dumbbells now go up to 60lbs. This addition was heavily requested and met with great appreciation. A multi-use plyo box was also purchased. Cost: \$1,310.





Fire Panel Replaced

A fire panel in the fitness center went bad and the alarm was set off. The fire department was dispatched, although there was no fire. 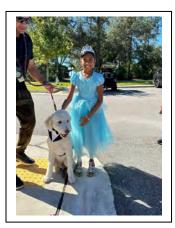

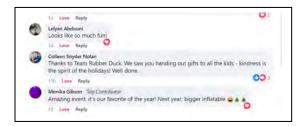
Black Friday Coffee & Donuts

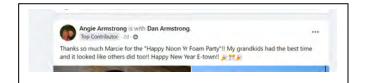

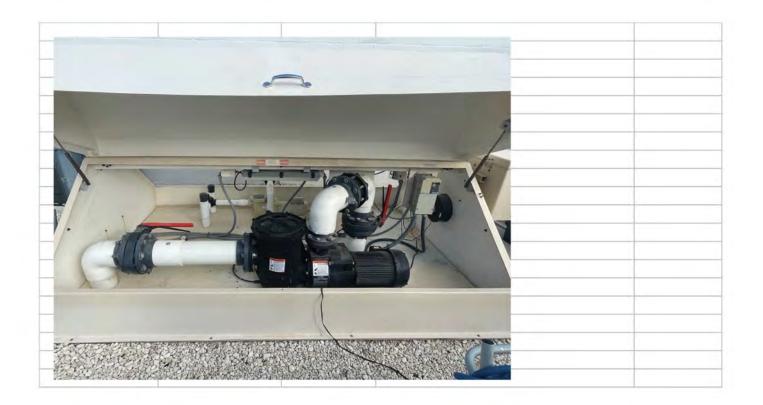

Description of Incident: At 1:05pm on Saturday 11/18/23 Isabelle Hansen, Guest Services Attendant, called Community Manager, Marcy Pollicino to report the fire alarm was going off at Recharge. Marcy inquired if any fire was on site. Isabelle responded no. Isabelle thought perhaps a fire panel had been pulled. Marcy had her check the pulls while on the phone and all were in the upright position. Marcy instructed Isabelle to hit silence on the fire panel, however the silencer was not working. In the meantime, Dynamic Security (fire alarm monitor company) called Marcy regarding the alarm to inform her they dispatched the fire department. Marcy explained what was happening to Dynamic Security and they patched Isabelle in on a three way call to try and stop the alarm. Dynamic Security contacted their supervisor, Ike Hayden who called Marcy in regards. Marcy got off the phone with Isabelle in order to talk to Ike and it should be noted Marcy was now on her way to Recharge. Upon arriving at Recharge, the alarm had timed out. The fire department had left, but in the interim had broken a circuit breaker trying to turn off the alarm. Marcy talked to Ike who walked her through how to turn off the alarm. The alarm was silenced; however, the emergency lights were still flashing at Recharge. Ike dispatched his technician to check it out. It was determined a fire panel had gone bad. The panel was removed from the wall and the emergency lights turned off. Dynamic Security returned on Monday, November 20 to replace the fire panel. Marcy also spoke with KAD Electric to replace the circuit breaker the fire department broke. They are ordering replacement parts.
